Parent/Guardian Code of Conduct

I will be a positive role model for my child and encourage sportsmanship by showing respect and courtesy, and by demonstrating positive support for all players, coaches, officials and spectators at every game, practice or other sporting event.

I will be respectful in public and display good character and be a model of sportsmanship as a representative of the Club.

I will never approach a head coach or member of the Club's staff to discuss playing time or the team's performance during scrimmages/leagues/tournaments.

I will never approach a line judge, official or scorekeeper before, during or after a match.

I will refrain from coaching my child or other players during games and practices, unless designated as an official coach of the team.

I will remember that the game is for the players, not adults.

I will follow all rules and policies of the host facility when at tournaments, hotels or other functions related to participating in events related to Olathe Girls Lacrosse (the "Club").

I will not encourage or participate in any behaviors or practices that would endanger the health and wellbeing of the athletes.

I will demand and enforce a sports environment for our child that is free from drugs, tobacco, and alcohol and I will refrain from their use at all events of the Club.

I will demand that my child treat other players, coaches, officials and spectators with respect regardless of race, gender, color, religion, national origin, age, disability, gender identity or sexual orientation and I will do the same.

I will be responsible when using the Internet and will not submit any negative information (comments, pictures, or other content) regarding my daughter's teammates, her team or the Club over social media.

I will be responsible while using messaging apps and will not submit any negative information (comments, pictures, or other content) regarding my daughter's teammates, her team or the Club via direct message, email or text.

I agree to handle any and all complaints in a professional manner and will observe the policy of waiting 24 hours after a scrimmage/league/tournament to make my complaint. All problems should be addressed to the Board of Directors. Do NOT contact your child's head coach prior to 24 hours. They will not respond per Club policies.

Procedure to Resolve Issues

- Step 1: Athlete meets with Coaching staff and/or Board Members to discuss concerns; If unable to resolve,
- Step 2: Board communicates with parents of player and player's Coaching staff; If unable to resolve,
- Step 3: Board Member(s), player, Coaching staff and parents meet.

I acknowledge that any violation of this Code of Conduct could result in my removal from the Club's events or tournaments as well as my child's suspension or termination from the Club's program.
