Player Contract

I will not engage in conduct that is inappropriate as determined by comparison to normally accepted behavior.

I will be respectful in public and display good character and be a model of sportsmanship as a representative of Olathe Girls Lacrosse (the "Club").

I will not transport, possess, distribute or drink any alcohol, tobacco(including vape products) or recreational/performance-enhancing drugs of any kind.

I will be responsible when using the Internet/messaging apps and will not submit any negative information (comments, pictures, or other content) regarding my teammates, team or the Club over social media.

I acknowledge that harassment, whether verbal, written or physical, based on race, gender, color, religion, national origin, age, disability, gender identity or sexual orientation is unacceptable and I will not engage in such conduct.

I will not engage in any activity that might constitute bullying. Bullying is defined as any verbal, written or physical conduct that is designed to demean, disgrace or cause mental or physical harm to another person.

I will not engage in any activity that might constitute hazing as that term is commonly defined.

I will not bring weapons, including, but not limited to, firearms or knives, to the Club's facility or any practice or performance venues.

I will not engage in any unwanted sexual and/or physical contact with other players in the Club. This includes, but is not limited to, hitting, touching, petting, pinching, or kissing. I will not make any unwelcome sexual flirtations, advances, requests, or invitations to any players in the Club.

I will accept the responsibility to manage my time in order to participate at the Club while maintaining balance and high standards with academics and family and will follow all rules and policies of the host facility when at tournaments, hotels or other functions related to participating in events related to the Club.

I will value the instruction of my coaches. Whether I think my coach is the best, the worst or somewhere in between, my job is to listen to my coaches, follow instruction, and make changes to improve my playing and sportsmanship. My coaches include my head coach, assistant coach, and any parent or volunteer coaches.

If I have a problem with a teammate, I will accept the responsibility to work it out with them. If I am unable to resolve the issue or I am uncomfortable with confronting the teammate, I will talk to the coaching staff to attempt to solve the problem. If I have a serious concern that cannot be resolved directly with my teammate or coaches, I understand I may bring the matter to the attention of a board member of the Club.

I will never question an official or express my feelings at an officiating decision. Officials are part of the game. I will never talk back or "show up" an official. This includes players that are performing officiating duties such as line judge or scorekeeping at an event.

I will attend every practice or play date to the best of my ability and understand that unexcused absences will not be tolerated and have consequences.

I acknowledge that I have a duty to protect my teammates and the other players and coaches in the club and will endeavor to report clear violations of this Code of Conduct to club management.

I acknowledge that any violation of this Code of Conduct could result in my immediate removal, suspension, or termination from the Club's program, its events, tournaments, programs or activities.
